□ 자진출국자 혜택

○ 불법체류에 따른 입국금지 조치가 면제됩니다.

※ 종전 자진출국 시에는 불법체류 기간에 따라 2년까지 입국 금지

○ 불법체류외국인과 그 고용주에 대해 범칙금이 면제됩니다.

○ 보호시설에 수용되지 않고 자유롭게 출국할 수 있습니다.

○ 출국 후 대한민국 공관에서 비자를 받아 다시 대한민국에 입국할 수 있습니다.

- ▶ 단속에 적발되어 강제추방되는 경우에는 불법체류 기간에 관계없이 5년 동안 입국이 금지됩니다.
- ▶ 불법 고용주에게는 고발 등 형사처벌이 강화되고 대폭 상향된 벌금이 부과됩니다.

□ 자진출국 절차

○ 자진출국을 희망하는 외국인은 당일 출국 항공권과 유효한 여권 또는 여행증명서를 가지고 전국 공·항만 출입국관리사무소에 방문하여 자진출국 신고 후 출국하시면 됩니다.

※ 다른 사람의 여권으로 입국하는 등 정상적인 방법으로 입국하지 않은 사람은 신원을 확인하는데 시간이 더 걸릴 수 있으니 출국하기 3일전까지 공항만 출입국관리사무소에 미리 연락을 하시기 바랍니다.

Miễn lệnh cấm nhập cảnh cho người bất hợp pháp xin đăng ký tự nguyện về nước

⌚ Thời gian thi hành : 2016.4.1 ~ 9.30.(6 tháng)

📍 Địa điểm đăng ký: Văn phòng xuất nhập cảnh ở các sân bay , bến cảng trên toàn quốc

📠 **Những quyền lợi của người xin tự nguyện về nước**

- ◎ Được miễn xử lí cấm nhập cảnh cho thời gian cư trú bất hợp pháp .
※ Trước đây khi xin tự nguyện về nước tùy theo thời gian cư trú bất hợp pháp thời gian cấm nhập cảnh tối đa là 2 năm.
- ◎ Người nước ngoài bất hợp pháp và chủ sử dụng lao động đều được miễn tiền phạt.
- ◎ Không bị tạm giam tại nơi bảo hộ người nước ngoài ,có thể tự do về nước.
- ◎ Sau khi xuất cảnh xin cấp visa lại tại Đại sứ quán Hàn Quốc và có thể nhập cảnh vào Hàn Quốc được.
 - ▶ Với trường hợp bị bắt và trục xuất về nước , không căn cứ vào thời gian cư trú bất hợp pháp đều bị cấm nhập cảnh 5 năm .
 - ▶ Đối với chủ sử dụng lao động nếu bị tố cáo sẽ bị xử lí phạt nặng và tăng cường mức tiền phạt .

✈ **Thủ tục đăng ký tự nguyện về nước**

- ◎ Người bất hợp pháp có nguyện vọng tự nguyện về nước cần mang theo vé máy bay và hộ chiếu còn hạn hoặc giấy thông hành tối Văn phòng xuất nhập cảnh ở các sân bay , bến cảng trên toàn quốc xin đăng ký làm thủ tục tự nguyện về nước và xuất cảnh là được .
※ Đối với những trường hợp đã không nhập cảnh bằng phương pháp thông thường hoặc dùng hộ chiếu của người khác nhập cảnh sẽ cần thời gian xác minh lại lai lịch nên ngày xuất cảnh cần đến sớm văn phòng xuất nhập cảnh ở sân bay để làm thủ tục .

Exemption from a re-entry ban for voluntary departure

Duration : 2016. 4. 1. ~ 9. 30. (6 months)

Place : Immigration offices at all ports of entry

Benefits for voluntary departure

- ◎ Exemption from the re-entry bans which were imposed due to the period of overstaying.
※ Previously, there was an exclusion period for up to 2 years depending on the length of overstaying
- ◎ Exemption from the penalty for illegal migrants and their employers.
- ◎ Leaving the country freely without detention.
- ◎ Entering the ROK after receiving the re-entry visa from the diplomatic mission abroad.

- ▶ If you were deported as you were caught by the authorities, you would be banned from returning for up to 5 years regardless of the period of overstaying.
- ▶ There would be enhanced criminal penalty including accusation, etc., and increased fines would be imposed as well.

Procedure for voluntary departure

- ◎ If you choose to return to your home country voluntarily, you should come with a flight ticket and valid passport or travel document and report your voluntary return status to immigration offices at all ports of entry on your departure date.
※ If you entered this country using a forged passport or any other abnormal ways, there will be more time needed for verification of identity. In these cases, you should visit immigration offices prior to the scheduled flight departure time.

关于非法滞留外国人 自愿离境后解除禁止入境措施的通知

实行期间 : 2016年04月01日~09月30日 (6个月)

实行场所 : 全国机场·港口出入国管理事务所

自愿离境者优惠

- ◎ 解除因非法滞留而导致的禁止入境措施。
 - ※ 截至目前, 非法滞留者自愿离境时, 按非法滞留时间, 至少2年内不可入境韩国。
- ◎ 对非法滞留外国人及其雇主免除罚款。
- ◎ 不关进外国人拘留所, 可以自由离开韩国。
- ◎ 出境后, 可以从大韩民国使领馆拿到签证并再入境大韩民国。
 - 如以非法滞留为由遭强制驱逐出境, 不管非法滞留时间, 至少5年内不可进入韩国。
 - 加强对非法滞留外国人雇主的举报等刑事处罚并大幅提高罚金额度。

自愿离境程序

- ◎ 要自愿离境的外国人在出境当日须持出境机票与有效签证或旅游证明书, 并访问全国机场或港口出入国管理事务所, 进行自愿离境申报后即可乘坐飞机。
 - ※ 如果以非正常方式进入韩国(用别人的护照入境韩国等), 确认身份时需要更长时间。由此, 出境当日应及早前往机场或港口的出入国管理事务所。

การยกเว้นอุกขั้นบัญชีสำหรับคนต่างด้าวผู้ที่อาศัยอย่างผิดกฎหมายแจ้งความจ้งขอเดินทางกลับประเทศไทยมิลำนานได้วยตนเอง

ระยะเวลา : ตั้งแต่ วันที่ 1 เมษายน ค.ศ. 2016 ถึง วันที่ 30 กันยายน (6 เดือน)

สถานที่ : ค่า�ตรวจคนเข้าเมืองทั่วประเทศซึ่งตั้งอยู่ในบริเวณท่าอากาศยานหรือเมืองท่า

ชาวต่างชาติที่อาศัยอย่างผิดกฎหมายแจ้งความจ้งขอเดินทางกลับประเทศไทยมิลำนาน มีผลประโยชน์ดังต่อไปนี้

- ◎ ได้รับการยกเว้นอุกขั้นบัญชีสำหรับคนต่างด้าวประเทศไทย
- ※ เดิมที่มีเมื่อการแจ้งความจ้งขอเดินทางกลับประเทศไทยมิลำนานด้วยตนเองของนั้น ชาวต่างชาติที่อาศัยอย่างผิดกฎหมาย จะอุกขั้นบัญชีสำหรับคนเข้ามายังที่ประเทศอย่างมากที่สุด 2 ปี ตามระยะเวลาที่พำนักอาศัยในประเทศไทยถือเป็นระยะเวลา
- ◎ ได้รับยกเว้นค่าปรับทั้งชาวต่างชาติที่อาศัยอย่างผิดกฎหมายและนายจ้างด้วย
- ◎ ไม่ถูกกักในสถานกักกันและสามารถเดินทางกลับสู่ประเทศไทยเดิมได้อย่างอิสระและมีภัยคุกคาม
- ◎ หลังจากเดินทางออกนอกประเทศไทยแล้ว สามารถเดินทางเข้ามาประเทศไทยหลังได้อีกโดยได้รับวีซ่าใหม่ที่สถานทูตภายหลัง

- ▶ กรณีที่ถูกขับบุกหลบหลีกฯ เก็บป่าไม้ทางคลองอุกขั้นบัญชีสำหรับคนต่างด้าวประเทศไทย เป็นกระทบไม่ถูกห้ามเข้ามายังประเทศไทยอีกเพียงคราวเดียว
- ▶ สำหรับคนเข้าเมืองที่วีซ่าเดินทางด้วยตัวเองที่อาศัยอย่างผิดกฎหมาย จะถูกแจ้งความจ้งเดินทางกลับสู่ประเทศไทยเดิมเดือนต่อเดือนโดยไม่กำหนดจำนวนเดือนที่เหลืออยู่และถูกห้ามเดินทางเข้ามาในประเทศไทยเป็นจำนวนเดือนที่มากขึ้นกับจำนวนเดือนที่เหลืออยู่

ขั้นตอนการแจ้งความจ้งขอเดินทางกลับประเทศไทยมิลำนานด้วยตนเอง

- ◎ ชาวต่างชาติที่ต้องการแจ้งความจ้งขอเดินทางกลับประเทศไทยมิลำนานด้วยตนเองให้นำหนังสือเดินทางที่ยังไม่หมดอายุหรือic(พาสปอร์ต)พร้อมด้วยเดินทางกลับสู่ประเทศไทยเดินทางภายในวันนั้นไปยังค่า�ตรวจคนเข้าเมืองทั่วประเทศซึ่งตั้งอยู่ในบริเวณท่าอากาศยานหรือเมืองท่า และสามารถเขียนชื่อบิน(ลงเรื่อง)ได้หลังดำเนินการแจ้งขอเดินทางกลับสู่ประเทศไทยมิลำนานด้วยตนเองเสร็จเรียบร้อยแล้ว
- ※ สำหรับผู้ที่เดินทางเข้าประเทศไทยเดิมอย่างผิดกฎหมาย เช่น ให้หนังสือเดินทางปลอม(หนังสือเดินทางของผู้อื่น) เป็นต้น ในวันเดินทางกลับประเทศไทยเดินทางเข้ามายังที่เดิมเดือนต่อเดือนโดยไม่กำหนดจำนวนเดือนที่เหลืออยู่และถูกห้ามเดินทางเข้ามาในประเทศไทยเป็นจำนวนเดือนที่มากขึ้นกับจำนวนเดือนที่เหลืออยู่
